## **Date**

Stroke Play over 4 x 18 holes for amateurs - women and men

Handicap-relevant and ranking effective for amateurs.

June 4<sup>th</sup> 2025 Training round (please reserve tee times directly at the host club)

June 5<sup>th</sup> 2025 Stroke Play 18 holes

June 6<sup>th</sup> 2025 Stroke Play 18 holes (Cut: men best 90 and equal)

June 7<sup>th</sup> 2025 Stroke Play 18 holes (cut: ladies best 21 and tie, men best 57 and equal)

June 8<sup>th</sup> 2025 stroke play 18 holes (final round women and men)

## **Terms**

The game is played according to the official golf rules (including amateur statute) of the R&A Rules Limited, the ÖGV Handicap Rules, the current ÖGV competition regulations (hard card) and the rules approved by the respective betting management.

For players with disabilities, reference is made to Rule 25.

## **Eligible**

are 141 amateurs (105 men, 36 women) excl. 15 Wild Cards\*, awarded by the Championship Committee and the ÖGV Sports Director Mag. Niki Zitny, who are members of a regular member club affiliated to the ÖGV or foreign association and have an **handicap index for women from max. 7.0 and in the men's of max. 5.0.**

With more than 156 entries, the players with the highest Hcp. Index eliminated from the betting management, with the same Hcp. Index decides the lot.

If the field of participants is not exhausted after the entry deadline, the ÖGV Sports Director together with the Tournament Director can also find starting places for higher HCP. Indices (up to Hcp. Index 8.0 men and 10.0 women) than provided for in the tender by means of wild cards. No applications necessary.

**\*Wild Cards:**

The ÖGV reserves the right to award a maximum of 15 wild cards, which will be decided by the Championship Committee and the ÖGV Sports Director Mag. Niki Zitny no later than 3 days after the entry deadline. Wild cards can only be awarded to named and eligible players. Applications for a Wild Card must be sent to Mag. Niki Zitny by e-mail: [zitny@golf.at](mailto:zitny@golf.at) by the registration deadline.

Ladies: The best 21 and equal players at the end of the 3rd round.

Men: The best 90 and equal players at the end of the 2nd round.

Men: The best 57 and equal players at the end of the 3rd round

Entries must generally be made (also for foreign players) via the online entry tool on <https://www.golf.at/sport/turniersport/verbandsturniere/>. To register, please click on the GREEN BUTTON next to the desired tournament. 

**Players without an active membership in an Austrian. Golf club,** need a user profile for the ÖGV MyGolf area to be mentioned at ÖGV tournaments. This can be

created by registering on golf.at, via **the**  **RED BUTTON** International Entries at the top of the website. For this purpose, an email address must be deposited, to which an automated registration link will subsequently be sent. For registration and registration for tournaments, the following data must be provided for contact, tournament processing and invoicing: first & last name, email, telephone number, nationality, date of birth, gender, WHI, home club, billing address. **Late entry:**

Until Monday June 2nd 2025, 14:00 o'clock a late entry with an increased green fee (50% more) is possible. The nomination must be made in writing to the ÖGV (Mr. Steinhardt peter.steinhardt@golf.at).

Players who are registered at the regulare entry deadline and are permanently qualified on the basis of the announcement cannot lose their eligibility by late entries.
